### Job Purpose

To lead an operationally focused data analytics function to support operations across Ofqual, in addition to delivering technical research projects in the field of assessment and qualifications, providing advanced statistical support across the directorate and managing the production of Official Statistics reports.

### Key Accountabilities:

- Designing, planning and delivering projects requiring technical analytic expertise that support delivery of Ofqual's strategic objectives.
- Performing research in the field of assessment and qualifications.
- Supporting the Associate Director: Research and Analysis and/or Associate Director: Standards and Comparability in identifying key areas of relevant analysis/research.
- Proactively working with the Associate Director: Strategy and Risk to deliver analytic solutions to supporting the management of risk.
- Providing research input to and collaborating with members of the relevant technical advisory groups and committees.
- Managing the production and delivery of Official Statistics reports including being Head of Profession for Statistics as part of the Government Statistician Group and liaising with the UK Statistics Authority.
- Working collaboratively across the organisation to provide informed statistical and analytics advice.
- Providing expert specialist statistical advice to other researchers in the Strategy, Risk and Research Directorate, as required.

- Managing and providing informed input to fulfilling internal and external requests for data.
- Line managing the statistics and analytics team and taking overall responsibility for the individual development plans for its members in line with the expectations of Ofqual and the Government Statistician Group.
- To perform any other reasonable duties as directed by line management.

#### **Corporate Accountabilities:**

- Supporting your manager with the delivery of the business and corporate plans for your area working flexibly and collaboratively with colleagues, partners and stakeholders.
- Supporting your manager in driving continuous improvement within your own areas.
- Acting as a role model for Ofqual's values and professional standards.
- Being fully aware of and actively complying with Ofqual's policies and procedures relevant to your own responsibilities and to corporate policies and procedures including equality, sustainability and the environment, and health and safety.
